The Bulan Water District (BWD), through its Bids and Awards Committee (BAC), invites suppliers for the DESIGN & BUILD FOR THE UPGRADING AND REHABILITATION OF BULAN WATER DISTRICT WATER SYSTEM (2018 – BWD – 002) to apply for Eligibility and if found eligible, to bid the hereunder Contract:

Name of Contract: **DESIGN & BUILD FOR THE UPGRADING AND REHABILITATION OF BULAN WATER DISTRICT WATER SYSTEM**

Location: From Brgy. Lajong Bulan, Sorsogon to corner Mercury Drugs (Zone 4) Zone 2 to Brgy. Aquino, Expansion of Sta. Remedios

Brief Description: Design and Build of Transmission Lines from the Surface Water to the Baranggays for Concessionaires of Bulan

Approved Budget for Contract: **Php 26, 000,000.00 - LWUA ICG Loan**

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% to 75% of the ABC. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria. All Bids must be accompanied by a Bid Security in the form stipulated in the Bid Documents. Late Bids shall not be accepted. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulation (IRR).

Prospective bidders shall submit the Bid Documents to the BAC at the said address on the prescribed deadline of submission.
